During April 2019 Elementos entered into a Loan Facility for \$2m with the Company's Non-Executive Chairman, Mr Andrew Greig. The loan is unsecured, has an interest rate of 6% and a term of 2 years. For further details see ASX Announcement released 17 April 2019.

On 6 August 2020, Elementos entered into an agreement with Mr Greig to convert \$500,000 of the outstanding loan balance to shares and options on the same terms of the recent Placement and Share Purchase Plan, the conversion of the loan amount is subject to shareholder approval at the AGM to be held on 16 November 2020.
