The loan is unsecured, has an interest rate of 6% and a term of 2 years. For further details see ASX Announcement released 17 April 2019.</p> <p>During April 2021, Elementos entered into an agreement with Mr Greig to convert the outstanding balance of the loan and accrued interest in two transactions as follows:</p> <ul style="list-style-type: none"> the exercise of 30,303,030 share options with an exercise price of \$0.009 per option. Funded through the conversion of \$272,727 of the outstanding loan balance; and the conversion of the balance of the loan amount being \$569,246, on the same terms as the placement announced on 19 April 2021. The conversion will result in the issue of 56,924,600 shares and 28,462,300 share options with an exercise price of \$0.015 and expiry of 30 April 2022. The loan balance conversion is subject to shareholder approval to be sought at an Extraordinary General Meeting planned for June 2021. To facilitate the shareholder approval and conversion process the loan maturity date has been extended to 30 June 2021.
