## Oropesa Tin Project – Drilling Progress Report.

### HIGHLIGHTS

- Significant zones of tin mineralisation continue to be intersected, confirming continuity
- Drilling program refinement completed reducing program to 44 holes (from 48)
- Oropesa drilling program on track to complete objectives with 77% drill holes completed

**Elementos Limited** (ASX:ELT) continues to confirm significant zones of mineralisation in its current drilling campaign at its flagship Oropesa Tin Project in Spain. Assays for a further five diamond drill holes have been received from the ALS laboratory. The latest drilling results are in addition to 22 diamond drill holes previously reported from this program. Significant zones of mineralisation interpreted from these latest results are shown below (0.1% Sn cut-off):

A full list of drill core assay results is shown in Table 2 on page 6.

Elementos CEO Mr Joe David commented, “The confirmation of the tin mineralisation continuity at Oropesa provides strong support that the company’s geological knowledge of the deposit is robust. This continued confirmation has led to the recent announcement (20 May, 2021) by the company to commence feasibility development programs on the project whilst the drilling program is in its final stages.”

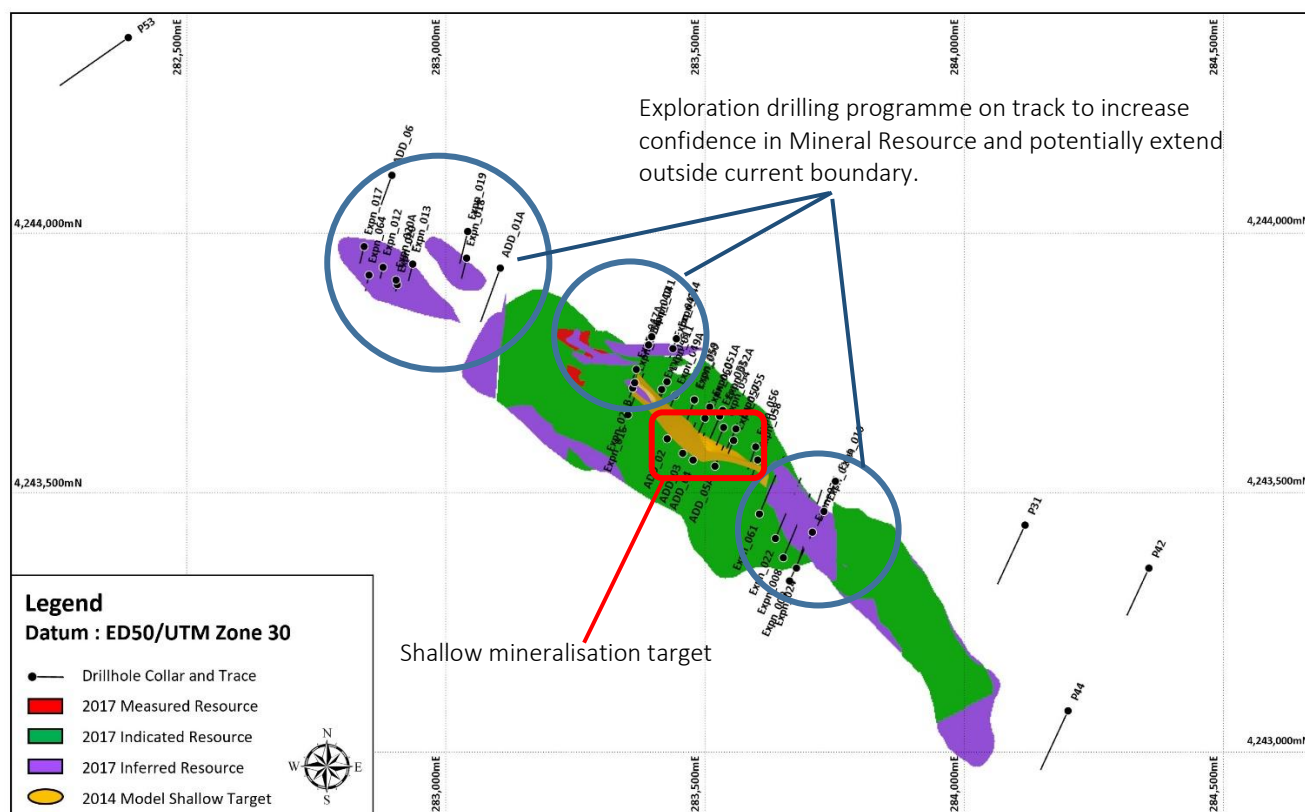


Figure 1. Oropesa geological resource depicting the location of the 2020-21 diamond drilling program.

The program's three principal objectives are:

1. To increase the confidence of existing Inferred Resources into Indicated Resources,
2. Confirmation of near surface, possibly fault controlled mineralisation that is currently not included in the 2017 geological resource model, and
3. Testing for additional near surface resources from exploration targets identified from Induced Polarisation (IP) geophysical survey anomalies.

The company has revised the proposed drilling program based on a review of information obtained from the drilling program to-date. The optimised program has been reduced to 44 drill holes (from the originally planned 48 drill holes) but adds an extra 270m of drilling (totalling 5,270m) due to the inclusion of two deeper resource conversion drill holes. At the time of reporting 34 (77%) drill holes had been completed with assays received for 27 of the completed drill holes.

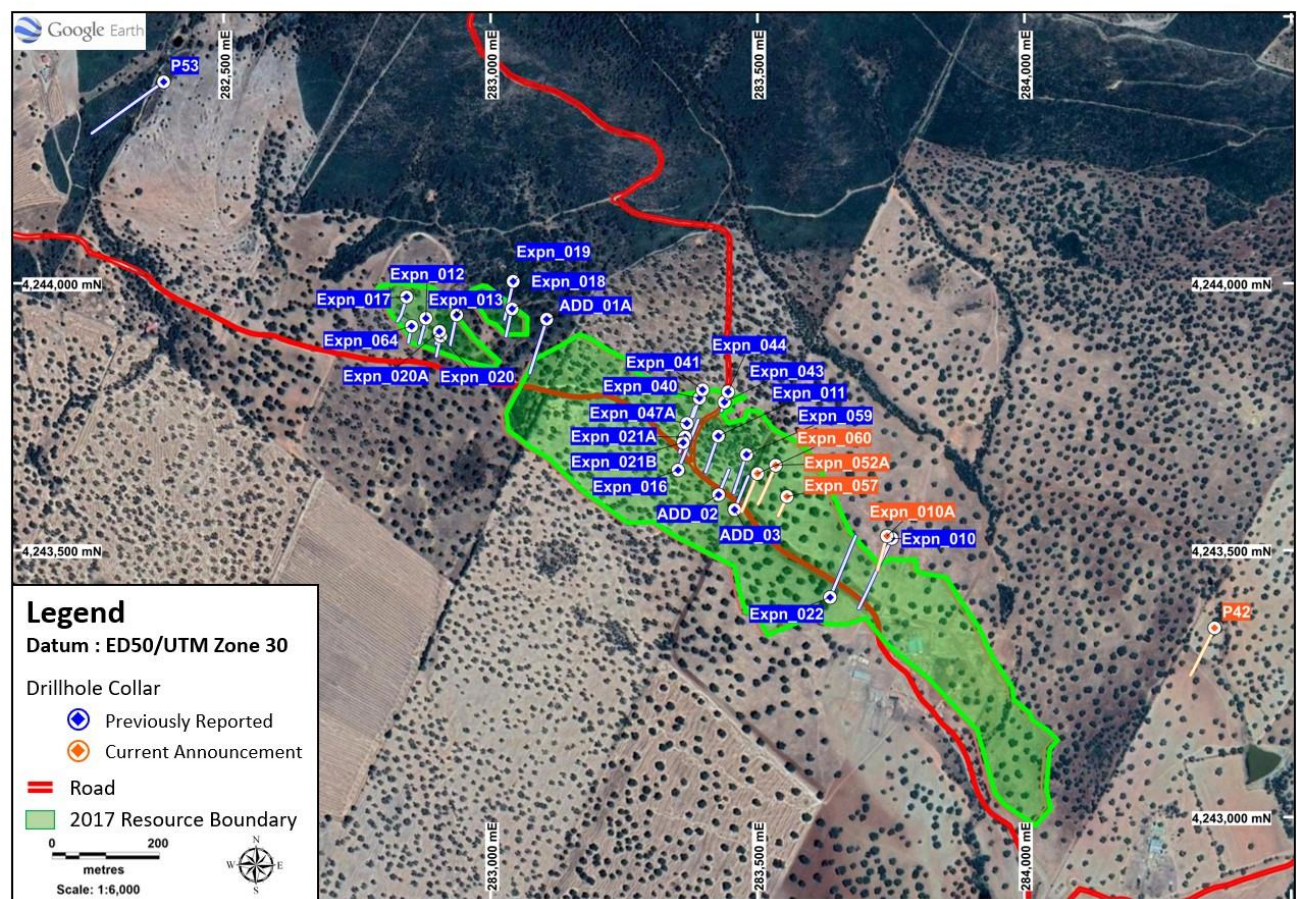


Figure 2. Location of drill holes with assay data as at 2<sup>nd</sup> June 2021, from the exploration drilling program at the Oropesa Tin Project, Spain

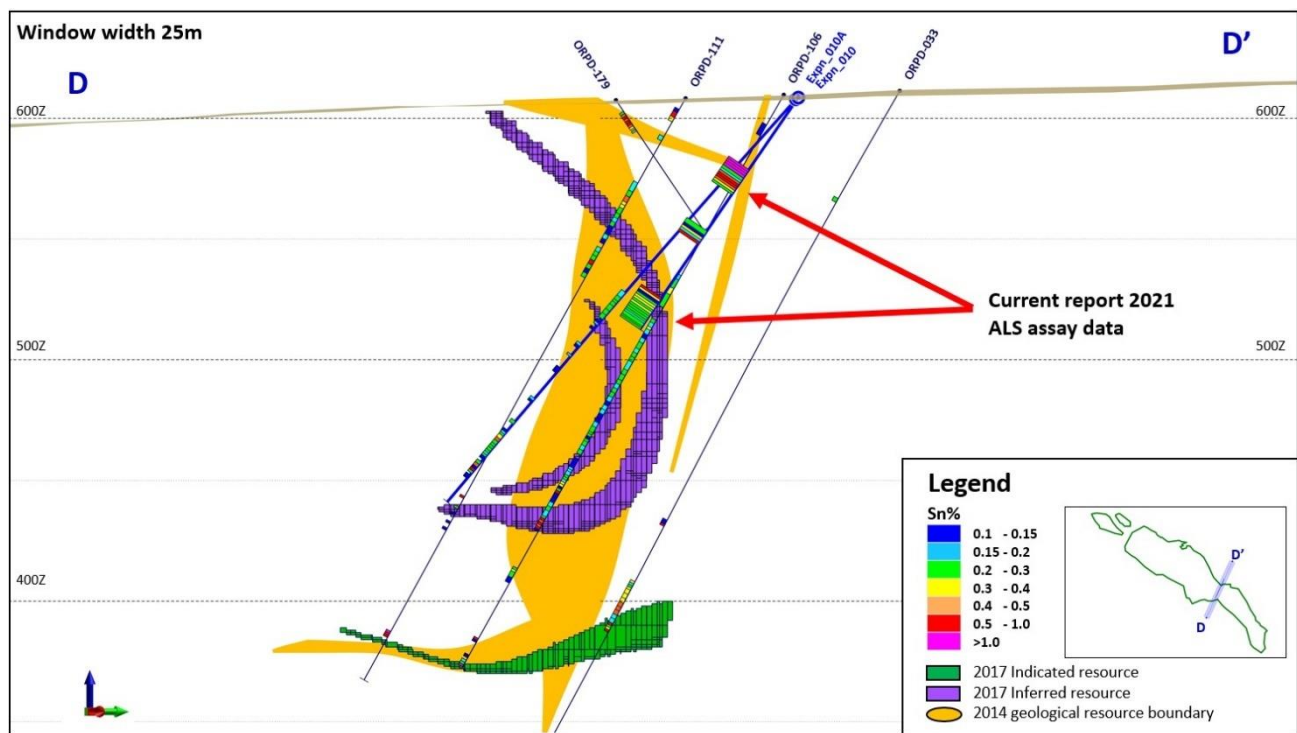


Figure 3. Oropesa 2021 resource infill diamond drilling, Expn\_010A



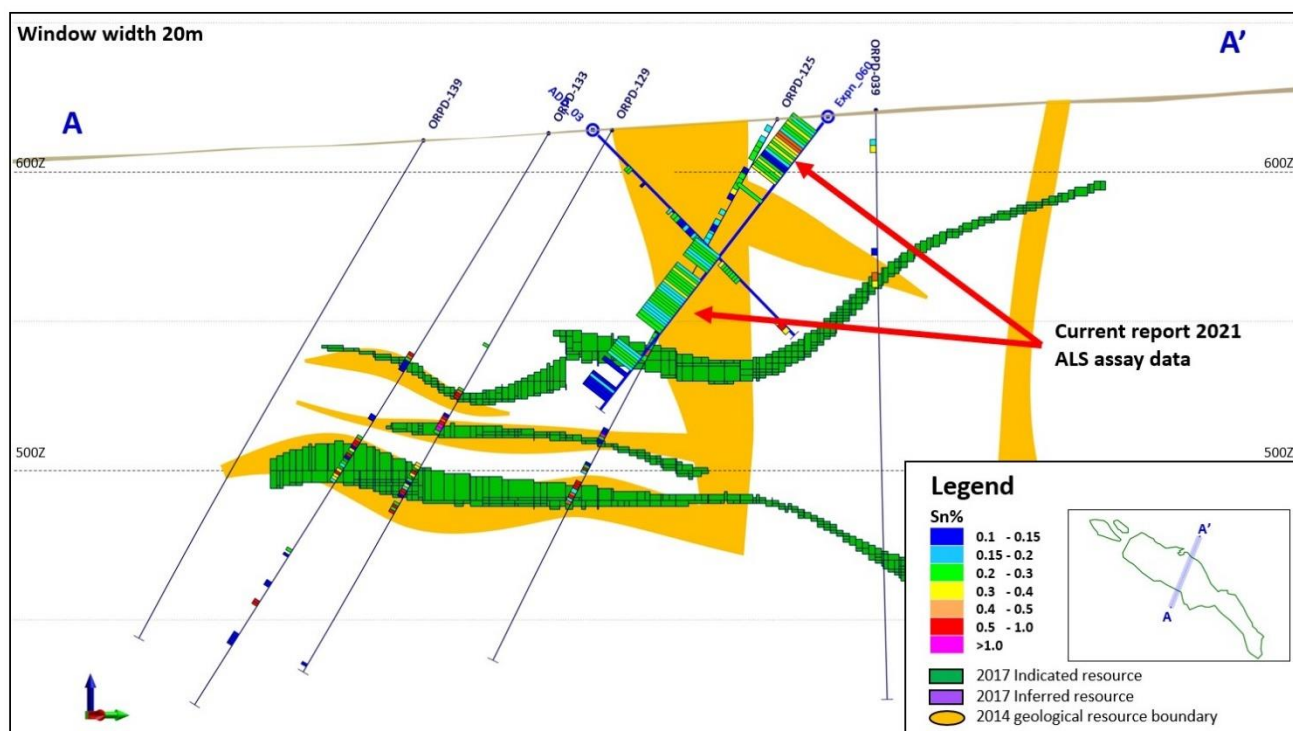


Figure 4. Oropesa 2021 resource infill diamond drilling, Expn\_060.

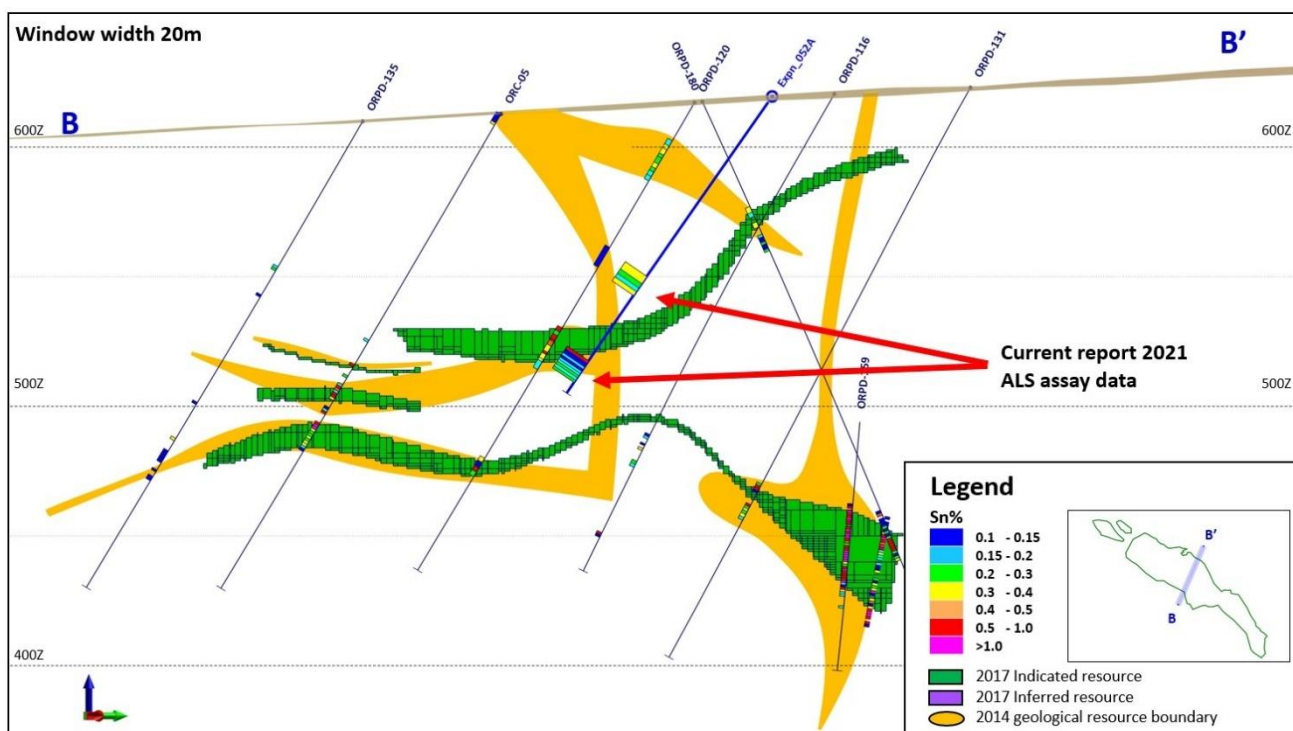


Figure 5. Oropesa 2021 resource infill diamond drilling, Expn\_052A

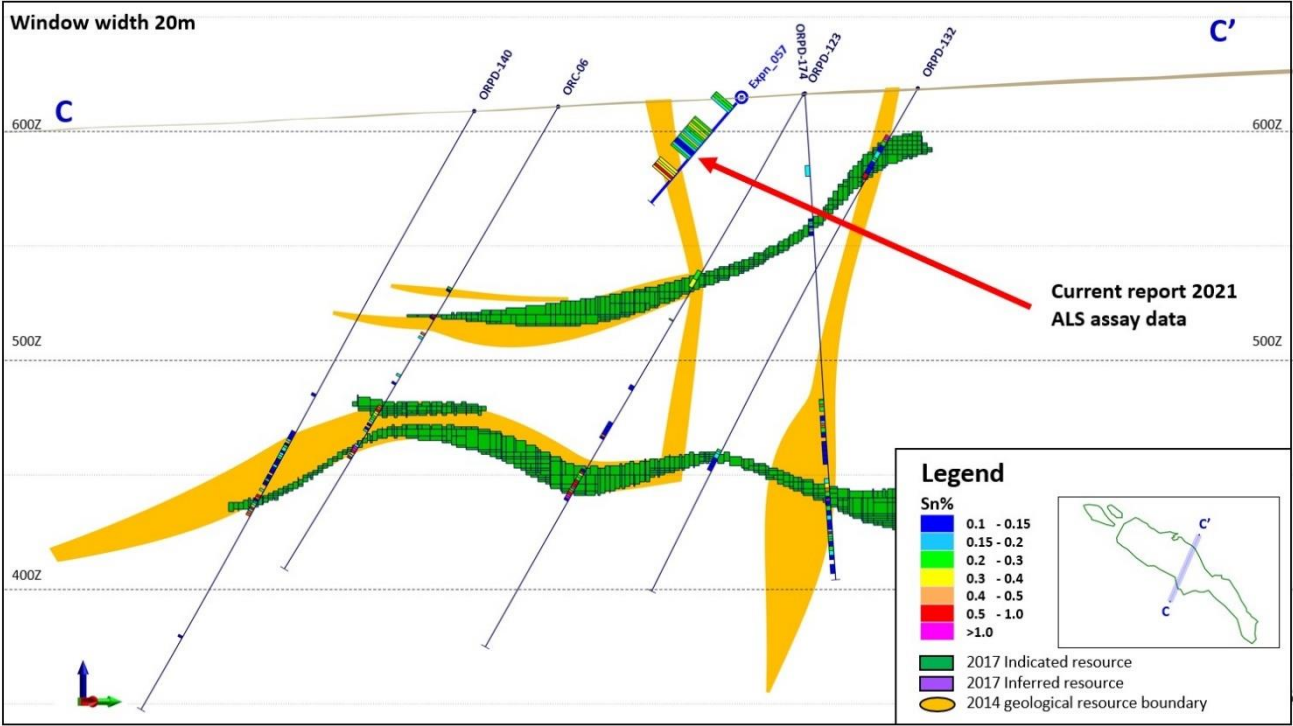


Figure 6. Oropesa 2021 resource infill diamond drilling, Expn\_057
