## Oropesa Tin Project – Drilling Progress Report

**Elementos Limited** (ASX:ELT) has confirmed additional zones of significant mineralisation at its wholly owned, flagship Oropesa Tin Project in Spain following the completion of its planned 44 diamond drill hold program (with two re-drills, totalling 46).

The results from the latest four drill hole assays are listed below (intersection  $\geq 1\text{m}$  &  $\text{Sn} \geq 0.1\%$ ), and follows assay data from 29 drill holes previously reported from this program. Assay data from an additional 11 drill holes remains outstanding.

Elementos Chief Executive Mr Joe David said the drill hole assay results accomplished two of the company's program goals.

"This data confirms the existence of relatively shallow mineralisation in the centre of the Resource (Expn\_056 & Expn\_058), intersecting mineralisation thicker than previously modelled," Mr David said.

"In addition, the lack of significant mineralisation intersected in hole P44 (outside of the 2018 Mineral Resource) adds value as a sterilisation hole, confirming this location is appropriate for the planned external waste stockpile, as per the 2020 Updated Economic Study.<sup>1</sup>

"These results continue to validate and increase confidence in the previously modelled Resource and mine infrastructure locations, propelling the project forward and confirming the company's DFS development strategy," he said.

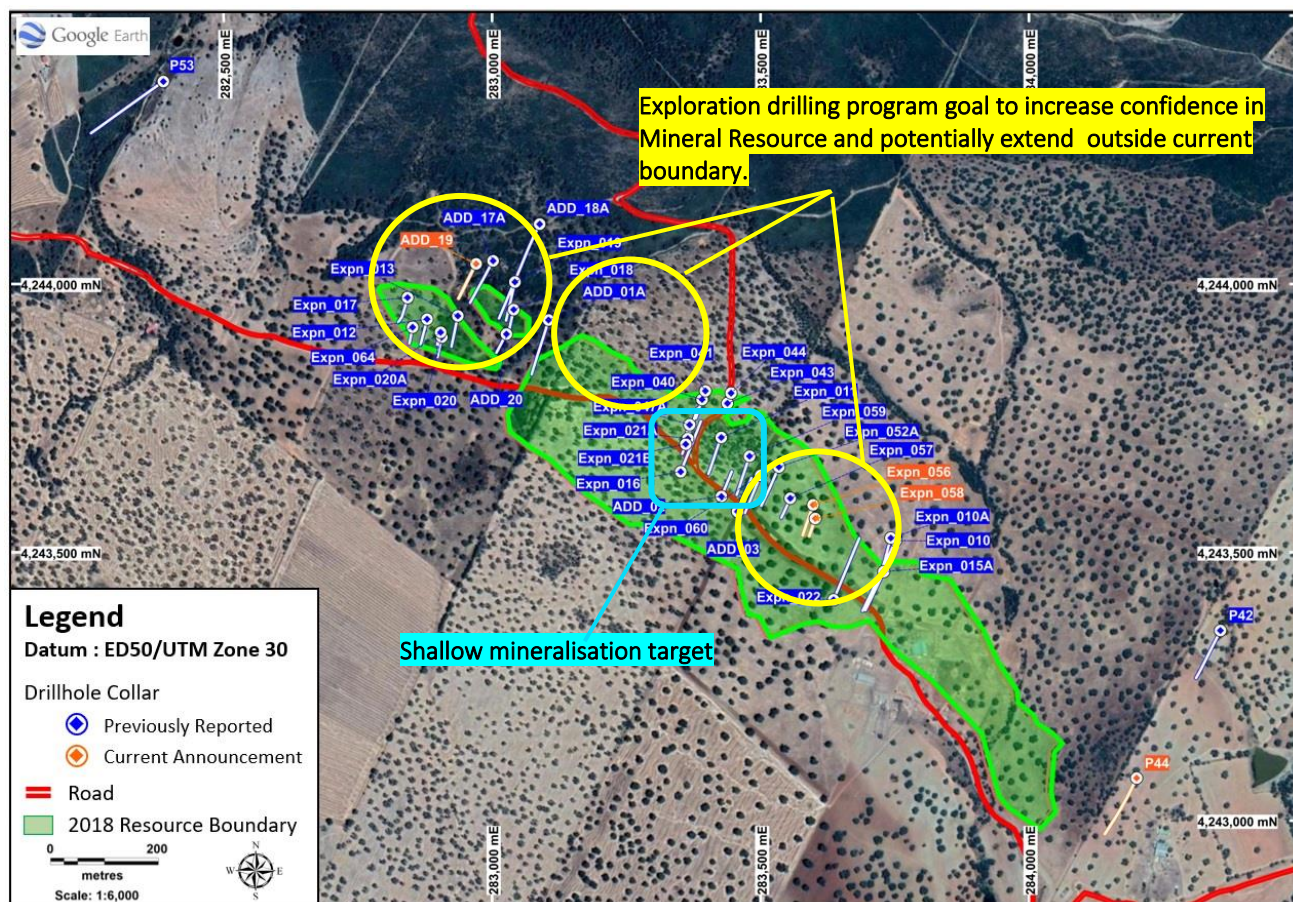


Figure 1. Location of drill holes with reported assay data as at 11th August 2021, from the exploration drilling program at the Oropesa Tin Project, Spain

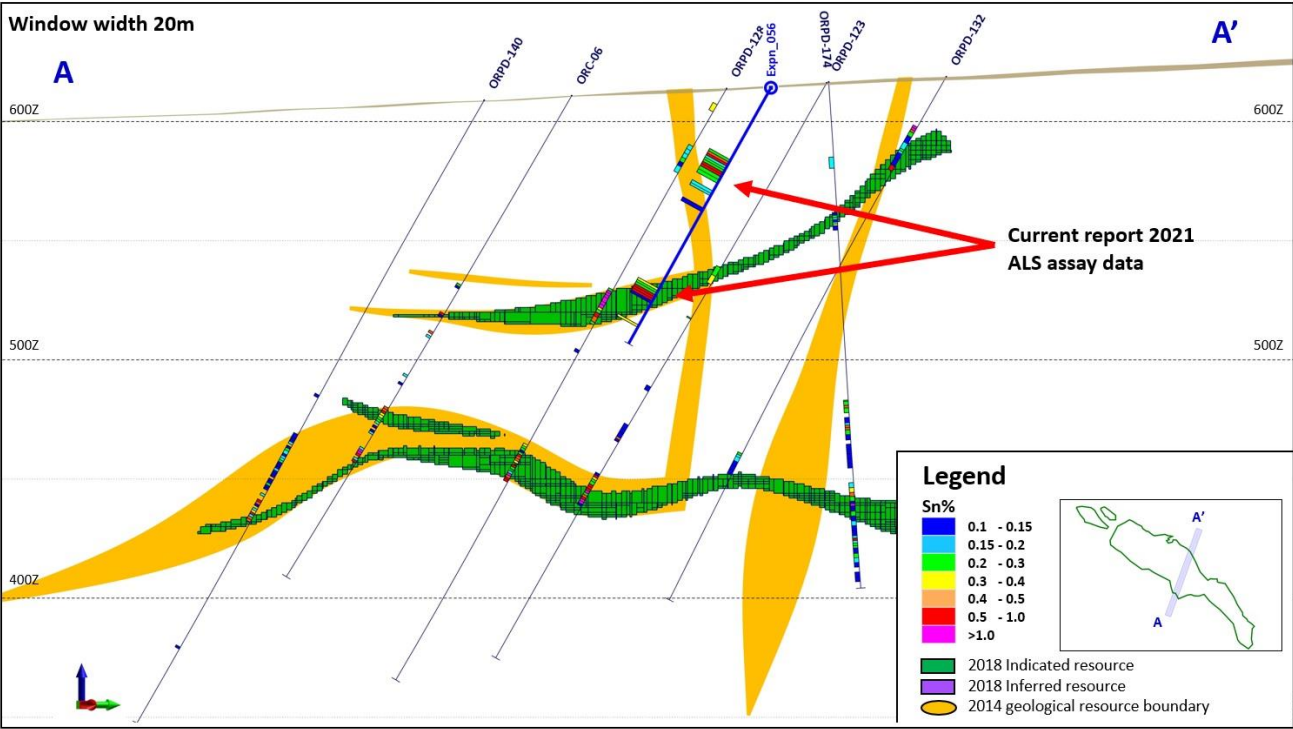


Figure 2. Oropesa 2021 resource infill diamond drilling, Expn\_056

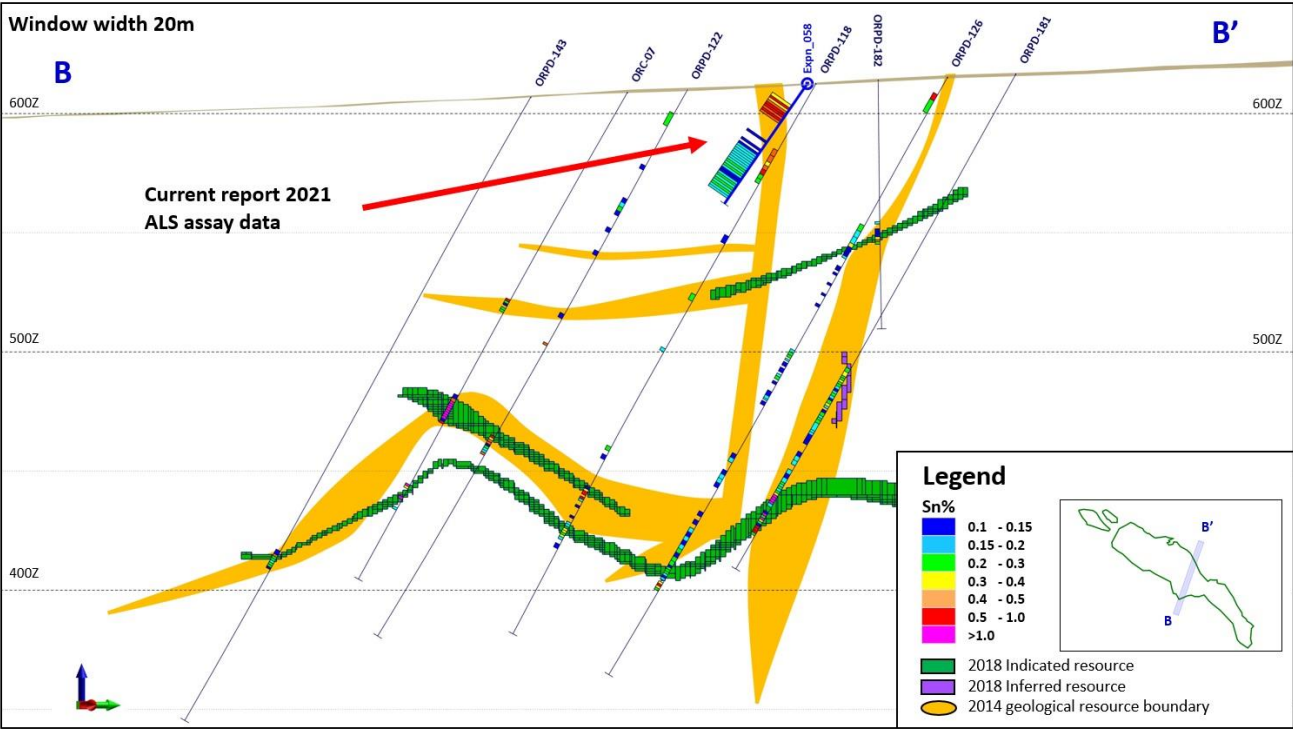


Figure 3. Oropesa 2021 resource infill diamond drilling, Expn\_058
